We have discussed using reclaimed wastewater for agriculture; this would not be potable water, but would be safe for agricultural use. The treatment plant currently uses recycled water as part of its operations, and we have been working to improve that system. Using reclaimed wastewater for agricultural uses would require the development of infrastructure to deliver the water to agricultural lands and agreement with landowners, and we have not progressed beyond the discussion stage at this time.

The newspaper mistakenly reported that the hearing examiner remanded the Center Street project to the town council. In actuality the hearing examiner's decision remanded certain questions to the town (concerning the viability and applicability of the 1986 agreement), and then the decision went on to say that the town should treat the remanded questions as something to be decided using the town's administrative process set out in its municipal code. So in other words the decision will be made by the town's planner, and appeals of the planner's decision would follow the normal process. I understand that the paper will issue a correction to that effect.
