TOWN OF LA CONNER PLANNING COMMISSION MEETING June 17, 2025

The Planning Commission meeting was called to order at 6:00 p.m.

Commissioners present: John Leaver, Cynthia Elliott, Carol Hedlin Sommer Holt, Youth Advisor Maxwell Page

PUBLIC COMMENT

There was no public comment.

MINUTES:

Commissioner Elliott moved to approve the minutes from the June 3, 2025 meeting. Seconded by Commissioner Holt. **Motion to approve the minutes carried unanimously.**

OLD BUSINESS:

There were no updates for the Public Participation Program.

Staff presented an updated version of the Comprehensive Plan based on comments received from the Department of Commerce. Commissioner Elliott noted that she recommended minor clarifying changes. Commissioner Elliott expressed deep concerns regarding language around the potential causes of racially disparate impacts. Commissioner Holt echoed these concerns. There was an extensive discussion regarding this section of the Comprehensive Plan. Staff will rewrite this section to address the concerns and present an updated version to Town Council, Planning Commission, and public.

Commissioners expressed concern regarding lack of review time, in particular for Element 12, the Climate Element.

Commissioner Hedlin moved to recommend approval of the Comprehensive Plan to Town Council, with the exception of Elements 6 and 12. Commissioner Leaver seconded. Commissioners Hedlin, Holt, and Leaver voted to approve the motion. Commissioner Elliott abstained. **The motion passed.**

NEW BUSINESS:

Commissioner Leaver opened the public hearing for LU25-31HDR at 6:43 pm. Staff explained that this project was to replace window with sliding doors. **Commissioner Hedlin moved to approve LU25-31HDR. Commissioner Holt seconded. Motion passed unanimously.**

COMMISSIONER COMMENTS/STAFF COMMENTS:

Staff thanked Commissioner Hedlin for her years of dedicated volunteer work on this Commission. Planner Davolio noted that this was his last meeting, stated that he enjoyed for La Conner and working with the Commission, and thanked them for all of their hard work and effort.

Debby Alrich spoke and noted that a lot of community members commented and contributed to this Comprehensive Plan, and she would like to give them a shout out.

With no further business Commissioner Hedlin moved to adjourn the meeting at 6:47 p.m. Seconded by Commissioner Holt. **Motion carried unanimously.**
