## **La Conner Logo Redesign Competition Guidelines and Rules:**

### **Competition Guidelines**

- Town of La Conner is accepting submissions between November 19<sup>th</sup>, 2025 and ending February 2<sup>nd</sup>, 2026.
- Artists over the age of 18 must fill out different application as this application is for minors only: "La Conner Logo Redesign Competition Application for Adult Submitters".
- Parent/Legal Guardian of a minor who wins of the Logo Contest must sign a "Logo Rebrand Trademark Assignment Agreement" on behalf of their child.
- New logo must be simple with easily understandable elements.
- Reads across clearly at all different sizes (scalable: looks good when very small and when very large) and on different platforms.
- Should be adaptable for black and white uses.
- Town suggests limiting your design to 3-4 (or fewer) colors.
- The logo should fit in a box or circle for ease of use.
- Must be digitally drawn or produced (acceptable formats include: JPEG or PDF).
- Submissions can be made by an individual or as a team (if submitting as a team each member of the team must fill out this Application).
- Artists are not required to be a resident of La Conner.
- There is no limit to a number of submissions an artist can have.
